Rules and Entry Form

Participants

All the participants, registered attendees and partners in the conference and symposium can participate.

Requirements

Be an adult, unpublished photographs that have not been presented in other competitions and / or contests. Affiliation of the author (name, phone, email and titration). Photography work printed on paper and in digital form.

Theme

The images will be subject related issues valuation bodily harm, forensics, pathology, clinical medicine, forensic pathology, laboratory, criminalistics, etc. They are rejected all those works that do not safeguard the anonymity of the photographed (if not included permission), pictures that violate the honor, privacy and respect for the image itself.

Format

It must be printed on photo paper. Photography measures may be 20x25 cm or 42x59 cm (din a2). The method and technique as well as color or B / W, is free. The photos are mounted on paper with pen margin between 2 and 10 cm, which are not protected by glass. The work should be identified on the back with the author's name and the title chosen by it. The digital medium is required to be in jpg, with maximum size of 5 Mb and approximately 300 dpi (dots per inch) resolution. Each participant may submit any reasonable number of photographs.

Term

The photographs will be presented **to the attention of Forensic Physician Dr. Joaquim Recio García in the Courts of Hospitalet de Llobregat (Building H), Medicoforense Clinic Service, 4th floor, Avenida del Carrilet 2, Barcelona's City of Justice , 08902 L'Hospitalet de Llobregat (Barcelona),** until the deadline of **November 15, 2017** inclusive.

On the other hand, e-mail to correu@acmf.cat the filiation of the author (name and surname, telephone number, e-mail and title), the photograph (s) presented / displayed in the contest, Title of the photograph (s) and a brief explanatory summary of the s (s). **Deadline: November 15, 2017.**

The costs of shipping and collection (in case of return) are borne by the participant. Shipping is at the risk of the author of the work. The return must be expressed by it, that is who covers the risks and expenses. They can also be delivered and collected at the indicated address.

The Organizing Committee will strive to preserve and protect the works, but is not responsible for hypothetical damage or loss thereof.

Jury

The Organizing Committee of the Conference and Symposium will form a **jury of members of the permanent** board to select the finalists, based on the representation of more akin subject and its technical and artistic quality. The result of the election of the winning works will be announced during the congress days. The decision of the jury is final.

Awards

All works opt for any of the awards, but only one award may be granted by the author. The jury will award a **first prize of 300 euros**, a **second prize of 150 euros** and three

special mentions without funding. In the latter itself may be repeating the same author, although it has managed to prize money. To all participants will be delivering a diploma certifying their participation in the event.

Acceptance of rules and authorization and assignment of rights

Participation in the contest implies the transfer in favor of the organization, by the contestants, the rights of reproduction and exhibition of photographs, provided they are used nonprofit. Original not rewarded may be collected by their authors or representatives in the three months after the congress, but the digital format can be used by the organization in scientific and nonprofit events. The winning photographs happen to belong to the Organizing Committee of the Conference-Symposium.

Participation in this competition implies acceptance by the contestants, each and every one of the bases described herein and take the final decisions of the jury, the latter being entitled to settle unforeseen circumstances.
